Invitation for Expression of Interest (EoI)

SELECTION OF ATTORNEYS AT LAW AND NOTARIES REFERENCE NO: EOI/05-2025/010

A. Introduction

The National Housing Development Company Ltd (NHDC) is presently compiling a list of **Attorneys at Law and Notaries.**

B. Background

The National Housing Development Company Ltd (NHDC) hereafter referred to as the Company, was incorporated in March 1991, as a Project Management and Property Development Company, to act as the Executive arm of Government in the Housing Sector.

C. Scope

The NHDC Ltd is looking to enlist a portfolio of:

1. Attorneys at Law

- (a) Advise and assist NHDC Ltd on actions against clients who are reluctant to sign their deeds of sale:
- (b) Advise and assist NHDC Ltd on actions against clients who have abandoned their units;
- (c) Prepare Eviction orders, Affidavit, Mise en Demeure, *Procedure de non-comparution* and other legal documents;
- (d) To be present for Election of Syndic process and respond to the NHDC beneficiary queries for a duration of 2-3hours;
- (e) To be present for Reunion d'information and respond to the NHDC beneficiary concerning any legal aspects such as extensions, Règlement de Copropriété, Civil code, their rights and obligations for a duration of 2-3hours;



- (f) To take appropriate legal action against clients for non-payment of their debts:
 - i. Letter to the defaulter,
 - ii. Mise en Demeure,
 - iii. Commandment Notice,
 - iv. Seizure Notice,
 - v. Assistance to sale by levy (if any),
 - vi. From sale by levy to receipt of Expedition,
 - vii. Any other fee related to the process above.

2. Notaries

- (a) To inform officially the NHDC of any property transactions carried out by an applicant and also to certify that a potential applicant is not already owner of any immoveable property;
- (b) To prepare deeds of sale and call clients for signature of deeds of sale;
- (c) To prepare Règlement de Copropriété;
- (d) To carry out searches at Registrar General's Office;
- (e) To certify that a potential buyer is not already owner of an immovable property;
- (f) To assist NHDC Ltd in legal aspects regarding sale of units, transfer of property, etc;
- (g) To prepare Prix d'Adjudication;
- (h) To prepare Liberation.

In this context, the NHDC Ltd is soliciting interested Attorneys at Law/Notaries to express their interests to provide the above-mentioned services for the NHDC Ltd.

D. Duration of the assignment

The duration of the assignment will be for a period of 24 months.

E. Requirements (for Attorneys at Law and Notaries)

In establishing a shortlist of potential bidders, the following documents will be used to determine the capability and experience of the Attorneys at Law and Notaries:

- a) Profile of the Attorneys/Notaries;
- b) Details of experience or similar assignments undertaken during the past 5 years; and
- c) Curriculum vitae of staff who could be available to work on the assignment.
